

Americans for Democratic Action Papers

1932 - 1973

In 1947 four hundred prominent Americans met to form a new political movement - the Americans for Democratic Action. Their aim was to establish a liberal organization dedicated to achieving worldwide freedom and economic security. The papers of the ADA trace the evolution of a modern political movement that supported civil rights, the United international control of atomic energy and global democracy. The 200,000 pages of ADA files contain records of campaigns on vital issues such as Vietnam, equal rights, disarmament, inflation and unemployment including correspondence with succeeding US Presidents and other major political figures.

Association of Southern Women for the Prevention of Lynching

1930 - 1942

Every civil rights and labor organization in America in the 20th century has fought against generations of ingrained prejudice and the bloodiest battles in the struggle for civil liberties have generally been fought in the South. And while various civil rights organizations such as the Commission on Interracial Cooperation (CIC) had effected many changes by the late 1920s and were gaining support and momentum in their work, much remained to be done. The Association of Southern Women for the Prevention of Lynching (ASWPL) took on the specific problem of hangings and provided inspiration to other organizations through its zealous efforts. This unique microfilm collection documents the work of the ASWPL as it set about putting a stop to an alarming increase in the number of African Americans being lynched in the rural South. Founded by Jessie Daniel Ames as a spin-off program of the CIC, this small group achieved much in its 12 years of existence. The papers of the ASWPL include correspondence, reports, pamphlets, legislative materials and meeting minutes that trace their determined fight to end the heinous and arbitrary hangings of African Americans. The public outcry caused by the ASWPL raised the consciousness of people in the South and in other areas of the country and as a result the number of lynchings decreased markedly. In 1942 the ASWPL ended its separate activities and merged back into the CIC. Researchers in the areas of women's studies, African-American studies, political science and American history will find that this collection fills a unique niche in civil rights research literature providing an interesting case study on one aspect of racial tension.

Papers of the Congress of Racial Equality

1941 - 1967

Over 60,000 pages of original records on microfilm providing a unique insight into the origins and development of the American civil rights movement. Founded in the early 1940s by a small interracial group of student activists from the University of Chicago, the Congress of Racial Equality grew both in power and influence to play a dominant role in the civil rights revolt of the 1960s. CORE's key position in the struggle for civil rights in America makes its records a major research resource, invaluable not only to social and political historians but to all researchers confronting the issue of race relations in their work.

The Papers of the Congress of Racial Equality (CORE): Addendum 1944 - 1968

In 1941 a small group of student activists in Chicago banded together, embracing Mahatma Gandhi's principles of nonviolent direct action in their fight against segregated housing and places of public accommodation. Within three years, this local cell had become a national organization that would, in the ensuing two decades, play a prominent role in the American civil rights movement. This collection offers materials recently released for micropublication and provides up-to-date information on CORE's history, strategies, tactics and ideologies. Students and scholars of 20th century American history, African-American studies, political science and sociology can follow the problems and perseverance of CORE in its fight for equal housing, equal employment opportunities, desegregated schools and transportation and black voters' rights. Among the numerous topics to be researched are:

- CORE's roots in the Christian-pacifist movement and its commitment to nonviolent direct action
- the instruments of social change the organization employed, such as sit-ins, boycotts and jail-ins
- CORE's organizational struggles, its decline in the 1950s due to the "Red Scare," and its re-emergence in the 1960s
- CORE's impact on the black student movement
- The Journey of Reconciliation, the Freedom Rides, desegregation and voter registration drives
- CORE's relationship with other civil rights organizations such as the Student Nonviolent Coordinating Committee, Southern Christian Leadership Conference, NAACP and the Urban League
- Many of Martin Luther King, Jr.'s personal papers

As a forerunner of the civil rights movement in its early days and a bulwark of civil rights activities in the 1960s, CORE's battlegrounds were often violent. This collection spans the years 1944-68, with the largest portion of material dealing with the 1961-68 period when CORE adopted a more militant strategy in response to the Black Power movement. The collection was filmed from the holdings of the Library and Archives of The Martin Luther King, Jr. Center for Nonviolent Social Change in Atlanta, Georgia

The Student Non-Violent Coordinating Committee Papers

1959 - 1972

One of the most important civil rights groups in late 1950 and early 1960, the Student Nonviolent Coordinating Committee (SNCC) was also to become one of the most controversial in its later years. Formed by student activists nationwide in response to the burgeoning student sit-in movement in 1960, the SNCC adopted the Gandhian theories of nonviolent direct action, which had been formulated by CORE in the 1940s. Now students in African-American studies, history, sociology and others interested in the civil rights movement can use this collection as a base of essential data for studying the projects, dynamic leaders and motives of the movement. The collection includes correspondence, project files, internal reports and printed materials generated by the SNCC organization as it challenged racial barriers, faced internal crises and sought a leadership role in the fight for desegregation, voter's rights and black power. The development of the SNCC can be assessed and compared with other organizations of the period. Among historical landmarks for study are:

- John Lewis' election as SNCC chairman in 1963, which signaled the start of the organization's most active period. SNCC field secretaries were involved in the Birmingham demonstrations and Lewis gave a major speech at the August 1963 March on Washington.
- The Mississippi Summer Project in 1964, which brought the SNCC national prominence. This massive project assembled hundreds of volunteers in the deep South to participate in voter registration and citizenship education drives. During this time, the SNCC also worked closely with CORE and the Southern Christian Leadership Conference.
- The election of Stokely Carmichael as SNCC chairman marked the radicalization of the group as Carmichael moved to identify the SNCC with the militant Black Power Movement. His action resulted in the resignation of many of the group's key leaders.
- The 1967 election of H. Rap Brown as chairman marked an even greater shift toward militarism. Brown's election, coupled with the SNCC's support of the Arab position during the Arab-Israeli War, cut off virtually all funding from white liberal supporters and led to the organization's collapse in 1970 from loss of leadership and funds.

Through the use of this valuable and historical collection, students can explore the ideals and impact of the SNCC as part of the Culture of Dissent and analyze parallels and differences between it and other civil rights organizations. The collection was filmed from the holdings of the Library and Archives of The Martin Luther King, Jr. Center for Nonviolent Social Change, Inc. in Atlanta, Georgia. The materials represent an essential tool for any complete study of the civil rights movement in America.

The Tuskegee Institute News Clipping File

1899 - 1966

Black disenfranchisement . . . the Scottsboro case . . . Dr. Martin Luther King, Jr. . . . the Civil Rights Act of 1964. The issues, events and people that make up the modern black experience in America and throughout the world are numerous and the history of this race is fraught with struggle and achievement. Students in black studies, American history and sociology can access a comprehensive file for researching 20th century black experience in the United States, Africa and throughout the world. The Tuskegee Institute News Clipping File contains hundreds of thousands of individual news clippings compiled from more than 300 major national dailies, leading Southeastern dailies, black newspapers, magazines, religious and special interest publications and foreign newspapers. Researchers will find primary source coverage on issues of concern to African Americans from 1899 to 1966. The history of black struggles and successes can be traced over the years through these materials and a special insight can be attained by viewing history through the eyes of the legitimate press. The file is augmented with significant correspondence, reports and speeches and covers a wide range of historical and contemporary topics including:

- Africa
- Civil rights
- Employment
- Music, poetry and art
- Segregation
- Anti-Negro groups
- Education
- Ku Klux Klan
- Race relations
- Racial consciousness

This remarkable resource was begun by eminent black sociologist Dr. Monroe Nathan Work of the Tuskegee Institute. As head of the Institute's Department of Records and Research, it was his responsibility to gather, organize and disseminate information about blacks. Dr. Work compiled information from newspapers and periodicals, press clipping bureaus, books, government statistics and reports, questionnaires, correspondence and other sources. Fortunately, his successors continued with the systematic collection of these materials. Filmed from the holdings of the Tuskegee Institute Archives, this collection represents a complete and descriptive record of the social, political, cultural and economic transitions throughout modern African-American history.

History

The African American Press Collection

1830-present

The title list for this collection was developed by an Advisory Board composed of key scholars. The collection includes 25 titles, the oldest of which are *Radical Abolitionist* (1855 – 1858) and *Principia* (1859 – 1864). This eclectic collection offers a rich store of information on African-American life encompassing issues such as history, social commentary, political advocacy, religion, education, literature and the arts among others. Black periodicals reflect the myriad of voices and perspectives of a people whose social history in America has been marked by the experiences of slavery, disfranchisement and achievement.

Although many people are aware of the significance and popularity of *Ebony* magazine and may know of its founder, John H. Johnson, few know that Johnson's first successful publishing venture was *Negro Digest*. In 1942 Johnson got the idea that the assorted tidbits of information on Black people could be marketed and sold in the manner of the popular mainstream magazine, *Reader's Digest*. Thus, *Negro Digest* was born with the assistance of a \$500 loan secured by his mother's furniture as collateral. In 1970 the title was changed to *Black World*. Johnson's second magazine, the aforementioned *Ebony*, debuted with the same size, look and feel of *Life* except African-American personalities, lifestyles and perspectives were the featured components. *Ebony*, began in 1945, just three years after he launched *Negro Digest*. This collection also contains a major *Ebony* competitor, *Sepia*, that ran from 1952 to 1982.

A wealth of material specifically related to Black American history can be found in the *Negro History Bulletin*, founded in 1937 and published by the Association for the Study of Afro-American Life and History. In the areas of African-American literature, social commentary and political advocacy, this collection offers several important periodicals spanning much of the 20th century. Included among these are *Crisis*, *Opportunity*, and *Freedomways*. *Crisis* is the official magazine of the National Association for the Advancement of Colored People (NAACP) and was founded in 1910. Its founding editor was W.E.B. Du Bois. Perhaps with the exception of the NAACP, the National Urban League has been the most influential national organization championing the causes of Black America. *Opportunity* was the Urban League's official publication and was contemporaneous with the NAACP's *Crisis* from its founding in 1923 until its demise in 1949. *Opportunity* became a forum for the writings of Harlem Renaissance figures such as Countee Cullen, Claude McKay, Angelena Weld Grimke and Gwendolyn Bennett. James Weldon Johnson and Langston Hughes, both contributors to *Crisis*, also saw their work published in *Opportunity*. *Freedomways* was a quarterly literary and social commentary magazine focusing on civil rights issues and pan-Africanism. It began in 1961 and continued until 1985.

Those who consult this collection primarily for sources in African-American literature and the arts will also find *Phylon Quarterly*, founded by W.E.B. DuBois and continued by Atlanta University, of interest. Other titles include *Black American Literature Forum*; *Black Theater*; and *The Black Perspective in Music*. The scholarly professional publications represented in the collection include some of the most important journals: *Journal of Negro Education*, *Journal of Negro History* and the *Journal of the National Medical Association*.

American Periodicals Series (APS I, II, III)

1741 - 1900

Researchers recognize that the literature and publications of a country are an important barometer of its political and social development. The more than 1,000 periodicals in these three microfilm collections provide the materials necessary to study trends in the United States from 1741 to 1900. Covering more than 150 years of American magazine journalism, American Periodicals is divided into three segments. Each covers a definite developmental phase in the history of America, spanning approximately 50 years. Individual reels may be purchased.

- **Series II: Growth & Change, 1800-1850**

The issue of slavery was debated widely and emotionally for decades before it divided the nation during the Civil War. The periodicals from the pre-war era included in American Periodicals Series II provide social historians with a wealth of literature on this volatile issue. Students will discover such materials as: *The Genius of Universal Emancipation* (1821-39), the first of the many abolitionist journals in this collection; William Lloyd Garrison's *Liberator* (1831-65), which became the most celebrated abolitionist periodical; and counterpoint publications such as *Southern Quarterly Review* (1842-57), which upheld the institution of slavery. The 911 titles in Series II demonstrate the rapid growth of periodicals after 1800 and include virtually all the significant magazines of the period. Hard-to-locate research materials, such as Poe's contributions to *Southern Literary Messenger* (1831-64) and Hawthorne's *New England Magazine* (1831-35), are available to literary researchers through this collection. The venerable *North American Review* (1815-1940) printed much of the era's leading literature including "Thanatopsis," and many other periodicals took literature or drama as their exclusive provinces. American Periodicals Series II also includes over 20 women's magazines that flourished during this period such as *Godey's Lady's Book* (1830-98), as well as children's magazines such as *The Youth's Companion* (1827-1927) and *Merry's Museum* (1841-72), which was edited for a time by Louisa May Alcott. - **Series III: Crisis & Reconstruction, 1850-1900**

Series III includes 118 periodicals from the Civil War and Reconstruction era published during the last half of the 19th century. This select grouping focuses on many of the early important professional journals, such as *Publications of the American Economic Association* and *Proceedings of the American Academy of Arts and Sciences*. This series also includes many celebrated titles issued by publishing houses—*Scribners*, *Harper's Bazaar*, *Lippincott's*, *Vanity Fair*, *Cosmopolitan* and *Ladies' Home Journal*. Students of marketing and advertising will find these popular periodicals useful in exploring the first examples of modern advertising slogans. Individual reels may be purchased.

Commission on Interracial Cooperation

1919 - 1944

When World War I ended in 1918, the United States jubilantly welcomed its soldiers home. America's finest young men had sacrificed their youth to fight for freedom on foreign soil and those who returned were given a hero's welcome. Returning black soldiers in the South, however, were being greeted differently. While white servicemen were honored for their valor, black soldiers who had fought shoulder-to-shoulder with their white comrades were now expected to resume their "proper place" as second-class citizens. Resentment grew and violent race riots resulted in several Southern cities.

The papers of the Commission on Interracial Cooperation (CIC), which was formed in 1919 in response to these civil disturbances, are now available in this microfilm collection. The CIC formed as a moderate coalition of whites and blacks, who recognized that promoting nonviolent change within the archaic Southern societal structure would in the long run better serve the cause of racial harmony. The CIC's purpose was relatively narrow by contemporary civil rights standards - to promote better race relations through public awareness and educational programs. They achieved their immediate objective of quelling the riots and relative peace settled into the South. Students in African-American studies, American history, political science and civil rights will use the official documents from the CIC extensively in research projects. Included in the collection are:

- Correspondence
- Minutes of CIC meetings
- Pamphlets and reports
- CIC educational material

This collection is divided into seven separate series to aid researchers in locating particular documents or subject areas. The CIC was to become the Southern Regional Council in 1944, an organization whose archives are also included in this catalog. Representing as it does the foundation for the later Southern Regional Council, this collection provides primary source background materials for any in-depth study of civil rights activities of the 20th century.

Federal Writers' Project

The lives of most people are rarely considered worthy of recording for historical purposes. Only recently have sociologists, historians and other scholars recognized the qualitative value of such information for obtaining well-rounded historical perspectives on an era. Federal Writers' Project preserves on microfiche over 12,000 manuscript pages documenting the personal histories of Southerners, which were collected through this New Deal program begun during the Depression. In these life histories, ordinary Southerners speak for themselves and what they have to say provides a unique view of the world they experienced and helped create. These people describe how major events affected them - the Civil War, Emancipation, World War I, the Depression. They speak of growing up, getting married, having children and getting old. They talk about family life, sex roles and religious beliefs. Students of American history, African-American studies, womens' studies, the family, sociology and the South will find the stories of these unknown Southern people of great value for research topics such as:

- Interrelating specific historical events to their effects at the grass-roots level
- A study of government social programs and the perceived accrued benefits to the programs' recipients
- Tracing social changes in the family and its structure, in the status of blacks during Reconstruction and in the roles of women in Southern society

This unique record of oral histories was filmed from the holdings of the Southern Historical Collection at the University of North Carolina, Chapel Hill. Institutions supporting or beginning a popular oral history program will also benefit from this model, which documents the lives of the normally voiceless, faceless everyday American.

The Hampton University Newspaper Clipping File

1900 - 1925

These clippings provide a unique journalistic record of black political, economic and cultural life in the early twentieth century with particular emphasis on the rural South. Virtually every facet of black life is covered from national events such as debates over voter disenfranchisement and Jim Crow legislation to local issues such as a black mother from Downingtown, Pennsylvania fighting the School Board order that would have sent her children to a segregated basement school.

Easily accessible on microfiche are full-length articles and brief sketches, cartoons, photographs, records and statistics from hundreds of newspapers which were preserved by Joe Louis' manager, Julian Black, in three sets of scrapbooks totaling 109 volumes. The collection is in three series: Black's own set, arranged chronologically by fight, 16 volumes which belonged to Louis, also arranged by fight and a single volume of random clippings from 1941-1944.

Records of the Fair Employment Practice Committee

1941 - 1946

Proclamations of equality and decrees of non-discrimination are at best hollow documents unless enforced by the governments and courts that mandated them. One of the landmark attempts at bridging this gap between theory and practice in the area of equal employment opportunity can be studied through this collection. Nearly all records of the Fair Employment Practice Committee (FEPC) during its five-year existence as a Federal investigatory agency is contained in this primary research source. Established in 1941 by Executive Order of Franklin D. Roosevelt to end discrimination against blacks in the defense industry, the Committee was charged to deal with any accusations of discrimination that might arise. In five years it investigated more than 14,000 complaints - 80 percent based on race, 14 percent on national origin and the remaining six percent on creed or religion. Students in African-American studies, labor history, social history, defense, economics and civil rights can access these records as a recent historical base collection for their research into contemporary labor discrimination.

Included in the more than 500,000 pages of official documents are: correspondence, case records, field reports from FEPC regional offices, minutes of FEPC meetings, internal studies, memoranda and individual workers' records. These documents are divided into two main series—Headquarters Records and Field Records. The latter series is subdivided into regional records covering the country. The FEPC dealt solely with the needs of minority workers and had specific jurisdiction over: complaints against the federal government, complaints against employers and employees' unions under contract with the federal government and complaints against employers and unions engaged in war production. Although the Committee depended on its powers of persuasion or on the cooperation of government agencies for enforcement authority, it contributed richly to promoting the cause of civil rights in the workplace. Offering as it does both statistical and human insights into labor and race relations, this collection is considered a primary research source, essential for any comprehensive study of civil liberties in America.

Regimental Histories of the American Civil War

Fort Sumter . . . Bull Run . . . Antietam . . . Shiloh . . . Gettysburg . . . The men who fought these battles in Union and Confederate uniform left both a collective legacy and their own personal marks on American history. These Civil War soldiers bequeathed to posterity many traces of their lives and their military struggles in journals, remembrances and personal accounts. In *Regimental Histories of the American Civil War*, ProQuest preserves items of historical interest accumulated during and after the war: regimental rosters, transportation documents, honor rolls and casualty statistics, promotion and court martial documents, memoranda and home addresses of veterans. Infantry, artillery and cavalry divisions are also covered. The collection contains personal and family papers and records, diaries, memoirs, biographical sketches, burial records, prisoner of war accounts, regimental reunion speeches, photographs, maps and illustrations. These records provide genealogists and Civil War historians with clues for tracing the movements of soldiers and their families during and after the war and give perspective to the evolution of the military conflict. The material begins in 1861 with early regimental recruitments and spans battles, negotiations, and the post-war lives of soldiers. The core collection is filmed at the U.S. Army Military History Institute at Carlisle Barracks in Pennsylvania. The Carlisle Barracks holdings include materials originally gathered by The U.S. Army War College, the National War College and the U.S. Army Command and General Staff College, as well as materials donated by individuals. Titles filmed in *Regimental Histories of the American Civil War* are previously unpublished works or materials published before 1915 and cover a variety of topics. The Schomburg Collection: Titles from the Schomburg Center for Research in Black Culture

1534 - 1955

The Schomburg Collection is a library within a library, being one of the Research Libraries of the New York Public Library. This truly remarkable aggregation of knowledge on all aspects of black history, civilization, arts and culture had its humble beginnings as the private library of Arthur A. Schomburg, a Puerto Rican of African descent, who has frequently been described as “the Sherlock Holmes of Black history...” – an accolade earned through his diligence in tracking down elusive manuscripts. In 1926 the Carnegie Corporation purchased his collection and presented it to the New York Public Library, where it became the nucleus of a constantly growing corpus of black materials. Today it contains over 65,000 volumes and 226,000 manuscripts (some of which date back to the sixteenth century), as well as thousands of prints, posters, photographs, films, magnetic tapes, records, sheet music and newspapers. Many of the Center’s unique holdings are available in this collection on 35mm microfilm, in two series of selected titles.

- **Series II, 1534-1955**

The second series of the Schomburg microfilm program contains more than 350 works dating from 1534 to 1955, many of which have been filmed from unique and rare editions. Because numerous titles consist of a very small number of pages, they have been grouped and filmed by subject or area and are not available individually. Subject sections in Series II of particular interest to African Studies researchers:

Section 1: Africa, the Matrix. (1600-1955)

This section takes a look at the Black motherland as the early European explorers, deskbound scholars and later colonizers saw her—at those ardent but frequently misguided individuals who sought lands in which to repatriate ex-slaves and other Blacks born abroad—at the indigenous fauna and flora, which captivated scientists and were despoiled by hunters—and the sincere and not so sincere, who came as interlopers and remained as “owners” and administrators of vast tracts of land belonging to others. Africa, The Matrix is where the history of all mankind begins.

Section 5: Religion and the Church. (1550-1904)

Biography, missions, sermons, church history and non-Christian ways of worship are featured here. Of special interest are an early nineteenth century Negro-English New Testament; Morgan Godwin’s work written in 1680 exhorting Christians to baptize Blacks and Indians as members of the Christian church; and the anonymous Young Prince, which relates the adventures of an African chieftain’s son, who was dispatched to England to learn about Christianity, so that his father might decide whether his people should adopt this religion.

Section 6: Slavery and the Slave Trade. (1685-1844)

This section covers: the horrors of enforced slavery of men of all colors and the insidious traffic in human beings; the facts marshaled by Benezet, Wilberforce, Ramsay, Clarkson, Pitt and others in their effort to abolish these twin evils; arguments against abolition and manumission; the great Parliamentary debates, which decided the issue for Great Britain and all lands controlled by her; and, amidst the strident white voices, those of the impassioned ex-slave Cugoano and of James Capitein, often cited as an example of Black intellectual potential, who penned one of the few books by Black men favoring the continuation of the institution of slavery.

Southern Regional Council Papers

1944 - 1968

After World War I, the South experienced violent and painful race riots spawned by the unequal treatment of black servicemen returning from the war. The moderate Commission on Interracial Cooperation, whose papers are included elsewhere in this catalog, was established to promote peaceful race relations. In 1942, America was again in the midst of a global conflict both in Europe and in Japan, and many CIC members recognized that there could be bloodshed again when black servicemen returned home and received unequal treatment. In addition, both black and white CIC leaders felt that the time had come to broaden the commitment of their organization and to push harder for civil rights for African Americans in all arenas of society. Thus, in 1944, the CIC disbanded and the Southern Regional Council (SRC) was formed.

The scope of the collection includes correspondence, internal records, reports, project files, pamphlets, newsletters and information on many related civil rights organizations. Through these materials, scholars can gain valuable insight into the SRC's strategies and ideologies as it developed a broader philosophy and fought for significant changes within the social, economic and political systems of the South. Students and researchers can access the papers of the SRC to assist in their examination of topics in African-American studies, American history, political science and civil rights. This microfilm collection provides a valuable primary research tool for such topics as:

- Examining the new directions the SRC took over those of its parent organization, the CIC
- Comparing the SRC's activities in areas such as integration and voting rights with those of other civil rights organizations
- The SRC's active work with the federal government to enact legislation in the civil rights arena
- The SRC's involvement and cooperation with other civil rights organizations such as the National Association for the Advancement of Colored People (NAACP), the National Urban League, the Congress on Racial Equality (CORE) and the Southern Christian Leadership Conference (SCLC)
- The SRC's active involvement with the Freedom Rides and voter registration drives sponsored by CORE

Filed from the archives at Atlanta University, this collection represents yet another vital link in ongoing studies of the 20th century civil rights movements in America.

Southern Tenant Farmers Union Papers

1934 - 1977

In its zeal to implement New Deal farm programs, the Roosevelt Administration caused the eviction of thousands of southern sharecropper families. Thus incensed, a handful of black and white farmers met in a schoolhouse in Arkansas and formed the Southern Tenant Farmers Union (STFU). This union was to become a powerful force in American labor and would eventually be a prototype for Cesar Chavez's United Farm Workers of America. The Southern Tenant Farmers Union Papers (also called "The Green Rising") encompass a multitude of issues, movements and individual histories on microform.

A major acquisition for any library's social science collection, these papers can be used by scholars and researchers investigating the historical perspectives of the New Deal, farm labor, or Southern, Mexican-American and American labor history. Founded by seven black and 11 white sharecroppers on an Arkansas cotton plantation, the STFU laid the groundwork for and contributed to the creation of the LaFollette Civil Liberties Committee in the U.S. Senate and the Kennedy-Johnson Administration's War on Poverty. The entire history of this influential union can be traced, from its humble beginnings under the auspices of the Socialist Party, through its brief and stormy affiliation with the CIO; from its entry into the AFL up to its merger into another union in the 1960s. A unique feature of this collection is the correspondence from sharecroppers to union officials. Notes scrawled on scraps of paper or penciled on the backs of outdated calendars tell of usurious landlords, sick children and flood conditions.

This supplement to the papers of the STFU features the personal papers and records of four of farm labor's dynamic leaders.

- **H.L. Mitchell Papers** - The private papers, subject files and printed materials of STFU co-founder H.L. Mitchell include unpublished and out-of-print studies of Mexican Americans and his correspondence documents STFU's Socialist Party origins.
- **Clyde Johnson Papers** - Documented is the life of Clyde Johnson, a dedicated trade unionist who was the last secretary to the Alabama Sharecroppers Union. Featured is an unpublished thesis by Dale Rosen, which documents the facts surrounding the Reeltown Massacre, as well as Johnson's oral history.
- **David S. Burgess Papers** - Insight into the lives of migrant workers during the 1940s can be gathered throughout the papers of David Burgess - a minister who saved the homes of 600 families in the Delmo Labor Homes Project of Southeast Missouri. In later years, Burgess was a CIO organizer and head of the Georgia CIO.
- **Thomas H. Gibbons Papers** - Gibbons' unpublished "Autobiography of a Technocrat" is based on the author's experiences as a migrant worker and his beliefs in radical economic theory.

State Secession Debates

1859 - 1862

One central issue which faced the fifteen southern and border states during the mid-nineteenth century was the question of slavery. Eleven states could not accept the programs of President Lincoln and seceded from the Union. Four states - Delaware, Kentucky, Maryland and Missouri - decided in either legislative session or convention not to secede from the Union. Black Literature

1827 - 1940

The importance of local black newspapers and periodicals as repositories of black creative writing is only now being fully recognized. It is as if a hermetically sealed library of Afro-American literature has been rediscovered after a century of neglect. Black Literature brings together for the first time novels, short stories, poems and reviews scattered throughout scarce black periodicals and newspapers giving students and scholars alike a unique opportunity to understand this vast body of American literature. 1827, the starting date, was the year when Freedom's Journal, the first black periodical was published. It seems that black authors, denied publication by mainstream American institutions, turned to their own local neighborhood newspapers and magazines to give voice to their literary concerns.

Many of these authors have been identified by the Black Periodical Fiction Project research team. While some were middle class, others were laborers or domestics who would come home after a long day's work and sit down to write a novel or short story or poem. Large numbers of the writers were women who often discuss sexual exploitation and the fact that black women had even less freedom than black men. Black Literature not only expands vastly the black literary tradition, this fascinating collection, full of vitality and imagination, is of immense social and historical significance in understanding the Afro-American experience in the 19th and 20th centuries.

Black Literature includes selections of fiction, poetry and literary reviews from prominent African-American newspapers, but does not duplicate the current events coverage contained in the complete microfilm of those newspapers.

George Washington Carver, the man who referred to himself simply as a “creative chemist,” accomplished much in his lifetime to promote racial harmony and black achievement as realities in American life. This historical archive traces the remarkable career of this slave-turned-scientist, providing a primary source for studies in African-American history. The Papers of George Washington Carver is the most complete collection of Carver’s public and private papers available to libraries.

The collection includes memorabilia, correspondence to and from Carver, Carver’s writings, writings about Carver and miscellaneous materials relating to his life and work collected both by Carver and the Carver Foundation. Carver received a master of science degree in agriculture from Iowa State and spent the better part of his professional life affiliated with Tuskegee Institute, then a struggling black trade school administered by Booker T. Washington. At Tuskegee, he chose to serve his race and Southern agriculture by teaching and demonstrating the application of scientific knowledge rather than by devoting his life to pure science. Ever an experimenter, Carver’s projects during these years were directed toward increasing the utilization and production of agricultural commodities. His contributions to Southern industry and agriculture made him respected and renowned and his fame was not limited to the United States. He became one of the leading authorities on subtropical agriculture and was consulted by individuals and governments in Latin America, Africa and southern Asia. Through this collection, researchers can explore in depth the many directions of Carver’s career:

- His early chemurgic experiments with the peanut and the resulting manufacture of approximately 300 peanut products ranging from wallboard to cosmetics to cough syrup
- Carver’s role in the Commission on Inter-Racial Cooperation, the Y.M.C.A and numerous prayer institutes to promote racial harmony and cooperation
- Carver’s controversial statements on his religious beliefs and his interest in mysticism
- historical information on Tuskegee Institute and Carver’s relationship with Booker T. Washington
- The founding and growth of the George Washington Carver Foundation for Agricultural Research at Tuskegee Institute

DuBois, W.E.B. The Papers of W.E.B DuBois

1877 - 1965

As one of the earliest and most influential spokesmen for African-American liberation, W.E.B. DuBois pioneered many of the strategies and programs of the American civil rights movement. This unique microfilm collection of DuBois's papers documents the private thoughts and public achievements of this radical leader for students of African-American studies, American history and political science. This important and comprehensive collection of correspondence reveals the many aspects of DuBois' illustrious career:

- As the nation's first black sociologist, DuBois dispelled the popular myths of racial inferiority through his scientific research.
- He later became the leading proponent of black separatism, calling for direct civil rights action as the only means of achieving social, political and economic equality.
- His condemnation of Booker T. Washington's theory of black accommodation
- His role in founding the Niagara Movement in 1905 and as one of the first leaders of the recently formed National Association for the Advancement of Colored People (NAACP) in 1910

DuBois was a historian and a prolific writer with 21 books and countless journal articles to his credit. Most famous of his books was *The Souls of Black Folk* (1903), and its lasting impact on both white and black consciousness is well documented in this collection. As an internationally known author and activist DuBois corresponded with some of the most important figures of his era, including Sherwood Anderson, Andrew Carnegie, Albert Einstein, Martin Luther King, Jr., Margaret Mead, Albert Schweitzer, Booker T. Washington and Roy Wilkins.

The Papers of W.E.B. DuBois provides insight into a critical period in modern social and political history through the eyes of a black leader. Students and scholars will find these papers a necessary part of their research into both the civil rights movement and DuBois's influence on it. Researchers can trace the changes in DuBois' political and social philosophy over the years as he shifted more and more toward radicalism and eventually became a member of the Communist Party of America at the age of 93. Kester, Howard A. The Howard A. Kester Papers

1923 - 1972

The birth and growth of the American labor movement often conjures images of the Northern industrial worker's plight in the factory. A significant and integral portion of organized labor's early struggles, however, took place in the fields of the rural South and Howard A. Kester was one of the earliest and most active proponents of tenant farmers' rights. The Howard A. Kester Papers documents the life and works of this man, who spearheaded many liberal causes in the South for over a half century. Students of political science, labor law and history and sociology will find this collection frees them from traditional reliance on secondary information in their research into the historical roots of the American labor movement. Although religious reform was one of Kester's early concerns as an ordained minister, his most notable achievement was in the field of labor as the founder of the powerful Southern Tenant Farmers Union.

The STFU was one of the earliest organized attempts to reshape traditional Southern attitudes on race relations, politics, religion, education and other issues. These efforts to improve the working conditions of the South's poor and oppressed provided the groundwork for the civil rights movement of the 1950s and 1960s. As these documents reflect, Kester was also active in education, serving as a teacher and dean of students at several colleges during his lifetime. This indefatigable activist also participated in many social action groups, including the Fellowship of Reconciliation and the Committee on Economic and Racial Justice. Featured in the collection are articles, reports, minutes of STFU meetings and Kester's correspondence with such prominent figures as Reinhold Niebuhr, Norman Thomas, John Nevin Sayre, Roy Wilkins, Thomas B. Cowan, Walter White and many others. The documents reveal Kester's many roles within the STFU as a keynote speaker at rallies, organizational philosopher and poet, polemicist and fund raiser and provide a wealth of information on subjects such as labor, economic reform, race relations and religious reform. An understanding of the American labor movement is vital to an understanding of American history or contemporary American society and these papers provide an important resource key to such research.

- **Lyman Family Papers, 1785-1956**

The Lyman Family Papers consists of account books, diaries, letterbooks, newspaper clippings, writings and scrapbooks of many generations of this illustrious New England family. The largest portion of the collection contains chiefly the papers of Theodore Lyman, Jr. (1792-1849), author, philanthropist and mayor of Boston and Theodore Lyman III (1833-1897), zoologist, Civil War aide-de-camp to Union General George Gordon Meade and Massachusetts congressman. Building a new nation out of a wilderness required vision, hard work and a strong sense of responsibility to future generations on the part of the early Americans. These pioneers had to create not only a stable political structure, but also a viable economic and social system - and the success of America depended on the solidity of these early foundations. The collected papers of both Peter Smith and his son, Gerrit Smith, span more than a century of important American history and provide a unique perspective on the vital issues of their eras. Both father and son made many valuable contributions to the economic and social development of America. Students of American history, political science and sociology will discover documents on land development and land reform among other issues. While Gerrit Smith was successful in expanding his father's business empire, his consuming passion was reform. One of his earliest concerns was religion and he was involved in the work of the American Sunday School Union and the American Home Missionary Society, among other organizations. These papers also include a wealth of material on Gerrit Smith's active involvement as an abolitionist. As President of the New York State Anti-Slavery Society, he published approximately 50 essays on slavery, helped slaves escape to Canada and in some cases purchased slaves and set them free. Gerrit was also an advocate of temperance, maintaining throughout his life that alcohol was responsible for most of the crime and poverty in the world. He supported women's rights movements and responded with speeches, funds and letters to requests for help from feminists such as Lucy Stone and Susan B. Anthony. The correspondence, business and land records, writings, files and maps featured in this collection reflect the many and diverse causes he supported during his lifetime. Van Dyke, Henry Jackson. Lectures and Sermons of Henry Jackson Van Dyke

1822 - 1891

The life of Henry Jackson Van Dyke, Sr. "tells more than the story of one individual," according to James H. Moorhead in the *Journal of Presbyterian History*: He was noted in the first part of his ministry as a conservative advocate of denominational particulars, a fierce opponent of abolitionism and a loyal friend of the South. Late in his career, Van Dyke worked for a broad church where theological tolerance would reign. A graduate of Princeton Theological Seminary, Van Dyke began his clerical career as pastor of the New School Second Church in Bridgeton, New Jersey, formed by dissidents from the Old School First Church. In time he decided he was an Old School pastor after all and moved on to an Old School ministry at the First Presbyterian Church in Brooklyn, New York, where he served the balance of his long career. Van Dyke's conservative views put him in opposition to the "Second Great Awakening" of religious revivalism sweeping the U.S. at the time. These spiritual and political awakenings, which ultimately led to the abolitionist and suffragist movements, attempted to wring social change from scripture. In contrast, Van Dyke believed with all his heart - and for most of his life - that social change was not the mission of the church.

The Lectures and Sermons collection reflects the extent to which Van Dyke's beliefs changed (in some cases greatly, in others not at all) during the course of his ministry. Perhaps his most famous sermon, delivered in 1860, excoriated abolitionism as "the chief cause of...the danger that threatens our country." Muted for most of the Civil War, he nonetheless published a pamphlet in 1864 taking vigorous exception to the Emancipation Proclamation. Following the war, the American Presbyterian Church began a process of reconciliation - Old and New School, North and South. As a conservative with ties to Southern churches, Van Dyke played an important role in mediating the Presbyterian General Assembly dispute of the 1870s. By the end of his life, he was able to declare, "If we cannot have liberty and orthodoxy, let us have liberty and go without orthodoxy." In Moorhead's words, he had become the "conservative apostle of a broad church." All the sermons and lectures in the ProQuest collection have been microfilmed from Van Dyke's handwritten originals, including both outlines and complete texts. Together they help historical researchers trace the evolution of American Protestant thought during a century marked by disputes over the very concept of polity, both doctrinal and political.

The Marshall Index: A Guide to Negro Periodical Literature

1940 - 1946

This seminal index represents the pioneering effort of a young African-American librarian to ensure that future researchers would have access to the contents of black periodical literature that was being ignored by traditional indexing services. Marshall started compiling citations for his index while working as an assistant librarian. In 1940, war loomed on the horizon and the country was still suffering from the effects of the Depression. With 3 x 5 cards, a shoebox and typed mimeograph stencils, Marshall embarked on his self-publishing venture and in 1941 Marshall mailed the first issue of A Guide to Negro Periodical Literature to a handful of subscribers. Titles in the premier issue included many leading African-American publications: *Crisis*, published by the National Association for the Advancement of Colored People; *Journal of Negro Education*; *Journal of Negro History*; *Opportunity*, the *Journal of the National Urban League*; and *Phylon*, published by Atlanta University. Author and subject entries in the Guide were filed together and subject headings were adapted from the *Readers' Guide to Periodical Literature*.

Details included book reviews, listed together and arranged by author, with reviewers' names included. Poetry appeared both as a subject heading and individually listed under their authors' names. By indexing a broad range of publications, Marshall was able to take note of the changing role of African Americans throughout American society and indeed across the world stage. Subjects ranged from military service to rural education; from the Fair Employment Practice Committee to the International Military Tribunal; and from Paul Robeson to Toussaint L'Ouverture. Marshall continued to publish his index until February 1943, when Uncle Sam requested his presence in the U.S. Coast Guard. After his discharge in 1946, two more issues were published, but by that time standard indexing sources had begun to include a few black periodicals and Marshall ended his solo efforts. But not before providing the academic community with a window into a pivotal and thought provoking world of African-American periodicals during the World War II era. With Albert Marshall's blessing, editors James Danky and Richard Newman have taken the original four volumes and created this new edition. Marshall's original indexing terms remain largely intact, with a few exceptions. Cross-references have been added to assist with subject access and name authority guidelines have been used to establish a preferred form. Whenever possible, original journal articles were compared to Marshall's index entry and citation information was verified and in some cases completed.

1724 - 1897

The Xavier University of New Orleans, the only Black Catholic Institute of Higher Education in the United States, possesses in its library a substantial collection of manuscripts relating to the North American slave trade during the period 1724-1897, including important documents from New Orleans dating from 1803 to early Reconstruction. Built up over 20 years by Charles F. Heartman, a Mississippi book-dealer, the Collection of over 4,000 pieces provides a fascinating insight into the civil and legal status of enslaved blacks.

The New Orleans Municipal Records are an extremely valuable source of information on the work and leisure activities of the 19th century slaves and the Xavier library also holds the only surviving manuscript of official slave-auction records. Other items include plantation accounts and estate appraisals, lists of slaves, private letters and bills-of-sale documenting the importation of slaves into Louisiana from Africa. The publication of the manuscripts on microfilm ensures that the priceless information offered by this unique collection is widely available and thus provides an unparalleled opportunity for research and study into the slave trade.

The Pennsylvania Abolition Society Papers

1775 - 1975

Even as the U.S. was in the midst of declaring its independence in 1775, a society was born in Philadelphia dedicated to emancipating America's black slaves. The Pennsylvania Abolition Society originated with the early anti-slavery activities of Philadelphia Quakers and its continuing efforts toward the cause of equal education and employment for blacks makes it the oldest such organization still in existence. The microfilm collection of the Society's papers charts the founding and the activities of this organization and contains primary sources central to a study of the American abolition movement both pre- and post-Civil War.

During the decades before and just after the Civil War, a historical collection of abolitionist documents was being compiled in the offices of two government officials. Salmon P. Chase (1808-73), member of the Lincoln Cabinet and Chief Justice of the Supreme Court and John P. Hale (1806-73), a distinguished lawyer and Senator from New Hampshire, were both active in the anti-slavery movement. Between them was accumulated a rich legacy of abolitionist materials now accessible to today's researchers. The 166 pamphlets, speeches, reports, legal opinions and convention proceedings, most printed in the 1840s and 1850s, examine the historical, legal, social and religious aspects of the slavery issue. Students in American history, black studies, the Civil War, and political science can examine such questions as:

- The Fugitive Slave Law of 1850
- The annexation of Texas
- The condition of freed slaves
- The forced emigration of blacks
- The constitutional rights of blacks

The writings of Theodore Parker, Sojourner Truth, Emma Willard, Daniel Webster, Alexis de Tocqueville and Horace Mann address the problem of slavery in America, while other tracts in the collection in French, Spanish and German provide insight into the slavery issue in the Caribbean during this same period. Several holdings in the collection illuminate the situation of freedmen just after the Civil War. These include the charter and bylaws of the Freedman's Savings and Trust Company of Washington, D.C., the minutes of the 1866 Freedmen's Convention, a 1867 issue of The Freedman's Record and several issues of The American Freedman (1866-67). The opposing viewpoint is represented in this material as well, with such pro-slavery views as John H. Van Evrie's *Negroes and Negro "Slavery": The First, an Inferior Race - the Latter, its Normal Condition* (1854). Historians particularly interested in the activities of the numerous societies and conventions to aid African Americans will discover useful information, such as:

- Convention proceedings and annual reports from the African Methodist Episcopal Church
- Convention materials from the 1853 Colored National Convention
- Documents of the American and Foreign Anti-Slavery Society
- Material from the Society of Friends, a group that supported the abolitionist movement

In addition, these pamphlets will help researchers study the Civil War and its causes and analyze the legal, religious and moral ramifications of American slavery on the U.S. then and now. The authoritative sources from the libraries of these two prominent government officials make this collection truly unique among abolitionist literature collections.

Sahel: Documents and Dissertations

In recent decades, world attention has been drawn to various areas of Africa affected by natural disasters. The most prevalent have been prolonged droughts and their devastating effects on the people in these precarious, underdeveloped economies. Response to these crises usually involve food airlifts to avert immediate disaster, but there exist few permanent programs designed to avoid drought-related losses. Sahel: Documents and Dissertations documents one cooperative effort in existence among eight independent nations along a 2,600-mile strip of West Africa known as the Sahel. In 1973, the Permanent Interstate Committee for Drought Control in the Sahel (CILSS, after the French initials) was formed by the governments of six countries most affected by a severe drought - Sénégal, Mauritania, Mali, Upper Volta (Burkina Faso), Niger and Chad. The countries of Gambia and Cape Verde joined later in coordinating planning efforts to avoid repeated drought-related disasters.

Researchers in African studies, agricultural economics and socio-economics will discover more than 1,000 documents and dissertations that report on the agricultural, economic and socio-economic changes in the Sahel region during and after the drought. This material - one of the only compilations of its kind in existence - provides fertile ground for studies of the effects of disasters on unstable economies. It also offers a model for an analysis of international cooperative efforts in Africa and elsewhere in the world. Featured are publications from African governments, research funded by USAID (U.S. Agency for International Development), dissertations, theses and reports from the United Nations CILSS, Club du Sahel and other international agencies.

Nearly half of the collection is in English, half is in French and two documents are in Portuguese. Titles in the collection are arranged by country, including informative profiles for each of the eight nations. A separate section covers the Sahel region overall. Nine hundred of the documents were selected by Dr. Joseph Lauer from Michigan State University's Sahel Documentation Center, one of the world's leading libraries of agriculture economic materials on the Sahel. The remaining 100 are American doctoral dissertations selected by Dr. Lauer from UMI's dissertation database.

With the Scramble for Africa and the subsequent 'pacification' of British territories, it was essential for the War Office to amass accurate information of possible strategic importance regarding the military and economic potential of indigenous populations, their histories and local topography and to organize this material in a form that would be readily available in the event of an emergency. Consequently, Colonial Office correspondence and other diverse sources, as well as military reports, were gleaned for local details which were then correlated to form comprehensive mosaics. In order to disseminate this intelligence, the corpus of information on individual territories was periodically printed for wider official use. Thus, for example, the Route Books and Military Reports provided comprehensive accounts of the country traversed, the location, size and condition of each village along the route, e.g. the number of huts, availability of water and provisions, populations, population estimates, etc., together with accompanying maps.

As for the Précis, which frequently run to several hundred pages, they most clearly resemble in scope and format the better known British Naval Intelligence Division, Geographical Handbook Series (Restricted) relating to foreign nations and territories which were produced during the Second World War. The Précis contain details on the geography, climate, harbours and communications, forts and docks, trade, bibliography and strategy. Compiled at the beginning of the colonial era, these long forgotten sources provide a basis for an assessment of subsequent changes with African societies and are invaluable for historical economic and political research.

Anti-Slavery International

Anti-Slavery International (formerly the Anti-Slavery Society) was originally founded as the British and Foreign Anti-Slavery Society in 1839. In 1909 it merged with the Aborigines' Protection Society. The society's collection of anti-slavery material, dating back as far as 1767, is unrivaled in scope, completeness and historical relevance. The Binns and Supplementary Collections comprises some 604 separate titles, bound in 25 volumes and covering every aspect of the anti-slavery movement. Numerous items predate the founding of the Society, including John Newton's Thoughts upon the African Slave Trade, London, 1788; Thomas Burgess's Considerations of the abolition of slavery and the slave trade, Oxford, 1789; and Thomas Clarkson's Essay on the comparative efficiency of regulation or abolition as applied to the slave trade, London, 1789.

The Binns Collection consists of approximately 50 volumes containing some 372 separate items, once the property of Thomas Binns, of Liverpool and donated by him to the Anti-Slavery Society. Included are such titles as Joseph Priestley's A sermon on the subject of the slave trade, Birmingham, 1788; Anthony Benezet's A caution to Great Britain and her Colonies..., London, 1767; An Address to the inhabitants of the British settlements in America, upon slavekeeping, Philadelphia, 1773; and Granville Sharp's The just limitation of Slavery..., London, 1776. Many of the volumes in these collections were presented to either Thomas Binns or the Anti-Slavery Society and are autographed by their respective authors; there is also a holograph letter by William Wilberforce.

The collection of Anti-Slavery material at the John Rylands Library is a wide-ranging and fascinating one which is of particular importance for the study of provincial philanthropic societies in England. As well as this, there are documents from Africa and many from the West Indies in addition to substantial papers concerning the American Civil War. The major part of this initial publication consists of the Wilson Anti-Slavery Collection, a large series of 19th century pamphlets donated by H.G. Wilson, the Member of Parliament for Sheffield.

Much of the material is extremely rare, with a substantial emphasis on publications issued in the region - especially Birmingham, Glasgow, Leeds, Manchester and Sheffield. The American Civil War material includes items from Boston, New York, Philadelphia and The Rochester Ladies Anti-Slavery Association. A substantial West Indian series emanates from Jamaica, together with many items from throughout the Caribbean. There is also an interesting series from India.

The Anti-Slavery Reporter

1825 - 1994

The Anti-Slavery Reporter was founded in 1825 by Zachary Macaulay (1768-1838), a Scottish philanthropist who devoted most of his life to the anti-slavery movement. At the age of 16 he was sent to Jamaica, where he eventually became a plantation manager, but his unhappiness with the treatment of slaves brought about his return to England in 1792. He then obtained an appointment to the council of the new African colony of Sierra Leone, founded by William Wilberforce and other abolitionists as a settlement for liberated slaves and became governor after his arrival there in 1793. His accomplishments in the colony were many, but difficulties finally forced him to resign his post in 1799. From 1799 to 1808 he was Secretary of the Sierra Leone Company in England. Under Macaulay and its subsequent editors, The Anti-Slavery Reporter campaigned vigorously for the abolition of slavery throughout the world. Its articles include detailed reports of the activities of the abolitionists; reports of the Parliamentary procedures which ultimately led to the abolition of slavery throughout Britain and her colonies; details of the political activities of pro- and anti-slavery supporters in other countries; and the Annual Reports of the British and Foreign Anti-Slavery Society (later the Anti-Slavery Society and now known as Anti-Slavery International.)

The collection at Rhodes House, Oxford, is a major unresearched source for the history of the anti-slavery movement in the 19th century. A major part of the collection relates to the British and Foreign Anti-Slavery Society. The Society was founded in 1839, its aim being to secure the abolition of slavery in general and in America in particular. It convened the first world Anti-Slavery Convention in 1840 and this was followed in 1842 and 1843 by further conferences. The greater part of the archive is the extensive correspondence from the secretaries and other officials of the Society, including such important figures as Thomas Pringle, John Scoble, Benjamin Millard, John Tredgold and Louis Chamerouzow. The letters are all arranged in alphabetical order. There are other letters from leading anti-slavery campaigners, with lesser or greater connections with the Society including such luminaries as Zachary Macaulay, Thomas Clarkson and the Gurney family and an interesting group of official letters from prime ministers, government offices, etc. to officers of the several societies.

To complete the very full archive there are also account books, rough minutes, attendance registers and papers from a general collection arranged according to territory and subject. The collection also contains papers from two other organizations set up to counter the evils of slavery. The Aborigines' Protection Society was founded in 1837 and was amalgamated with the British and Foreign Anti-Slavery Society in 1909. The collection at Rhodes House includes some important Minutes and Secretaries' Correspondence, as well as papers arranged according to territory and subject. Finally, there are 14 volumes of letters received by the secretary and trustees of the Mico Charity from the superintendents and teachers of the schools that the Charity had set up. These had been established following the abolition of West Indian Slavery in 1834, in order to educate the ex-slaves and their children in a period of apprenticeship that was to serve as a preliminary to complete emancipation. The collection dates from 1835-1842 and the letters are organized by island.

The Slave Trade and Abolitionism in France

1700 - 1900

It was only "for the good of their souls" that Louis XIII authorized the French trade in African slaves in 1642. By 1656 there were 3000 slaves in Guadeloupe; during the last quarter of the 17th century, 124,000 slaves were brought to the West Indies; and in the decade preceding the Revolution, the French captured and exported an average of 27,000 African slaves per year. The French slave trade—suspended by the Revolution, reinstated by Napoleon and permanently abolished in 1848—aroused fierce opposition and equally heated partisan defense. This collection includes rare 18th century descriptive works on the regulation of the trade and polemical works on both sides of the controversy, along with 19th century statistical surveys, accounts of the economics of the trade, descriptions of slave voyages and proceedings of official commissions.
